How To Become A Security Guard in Manitoba - Security ...

27.1(1) No person who is licensed to provide security guards or registered as a security guard employer shall use the expression "law enforcement officer" or "protection officer", or any variation or derivation of those expressions, in connection with the business of providing security guards or the employment of a security guard.
